

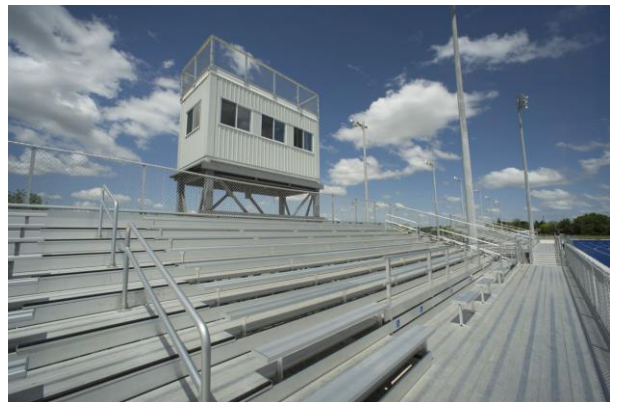

Tyke: Born in 2008 and 2009 (9 – 10 years)
100m, 200m, 400m, 800m, 1200m, 60m Hurdles, 4 x 100m Relay,
Long Jump, Shot Put

Atom: Born in 2006 and 2007 (11 – 12 years)
100m, 200m, 400m, 800m, 1500m, 60m Hurdles, 4 x 100m Relay,
Long Jump, Shot Put

Senior: Born in 2004 and 2005 (13 – 14 years)
100m, 200m, 400m, 800m, 1500m, 80m Hurdles, 4 x 100m Relay,
Long Jump, Shot Put

Relay: COAHCES & PARENTS 4x100 RELAY

- Team must be co-ed with a minimum of one (1) female
- No fees for this event

INDIVIDUAL PARTICIPATION

Athletes may compete in **three (3) events** of which **only two (2) can be track events, excluding relays.**

- ❖ Entry deadline will be on Wednesday, June 20, 2018 at 11:59 pm (EST).
- ❖ Meet Packages will be available for pick up at the field at the registration desk beginning at 8:00 a.m. on meet day.

AWARDS

Medals will be presented to the 1st, 2nd, and 3rd place finishers in each event. Ribbons will be presented to 4th to 8th place finishers.

NOTES

- ❖ Waiver forms must be filled out and submitted by each athlete or a blanket waiver by the coach with power of attorney (list all athletes). Athletes without signed waiver forms will not be allowed to compete.
- ❖ Events with less than five athletes may be combined with another age division.





GENERAL RULES

Track events take precedence over field schedules. If the timing of the field and track event conflict, the athlete must check in at both events, notify both officials of the conflict and be ready to run when the race is started. The athlete will be able to return to the field event once they completed their race.

MEET SCHEDULE

The Meet will be conducted based on a **“rolling” schedule**. However, the order of events as listed, will be maintained unless otherwise informed. On the condition that the schedule is revised, you will receive one in your Meet Package.
