Born in 1999 or later

#### **ENTRY DEADLINE**

Registration deadline is 11:59PM, Monday July 1st, 2019. After this deadline, late fees will be charged!

Trackie Reg will officially close at NOON on Tuesday, July 2<sup>nd</sup>, 2019.

There will be NO entries accepted onsite.

#### **GENERAL MEET INFORMATION**

Marshalling for track events will occur at the start line for each race. Field event athletes will check in at the event.

Heats and Finals have been scheduled for the WCSG 100m, 200m, and 400m. If there are 8 or less entries in any of these events, we will update the schedule and run a straight final at the Finals time.

Separate WCSG sections will be run for 800m, 1500m, and 3000m.

If numbers are low for any one particular event, Open athletes MAY be moved into the WCSG sections. This will be determined on an event by event basis, once entries have been confirmed.

## WCSG TEAM SELECTION - APPEALS PROCESS

Only athletes who are eligible to be considered for selection (i.e. have met the athlete eligibility requirements) and who have achieved a standard in 2019 may submit a letter of appeal for selection.

Appeals are only accepted if an athlete is not able to compete in their event at the trials. All appeal letters, whether medical or extenuating circumstances, must be submitted along with supporting documentation indicating that the athlete will be competition ready in time for the Games.

These appeal letters must be submitted to the Head Coach or Team Manager prior to the start of the WCSG Trials.
