

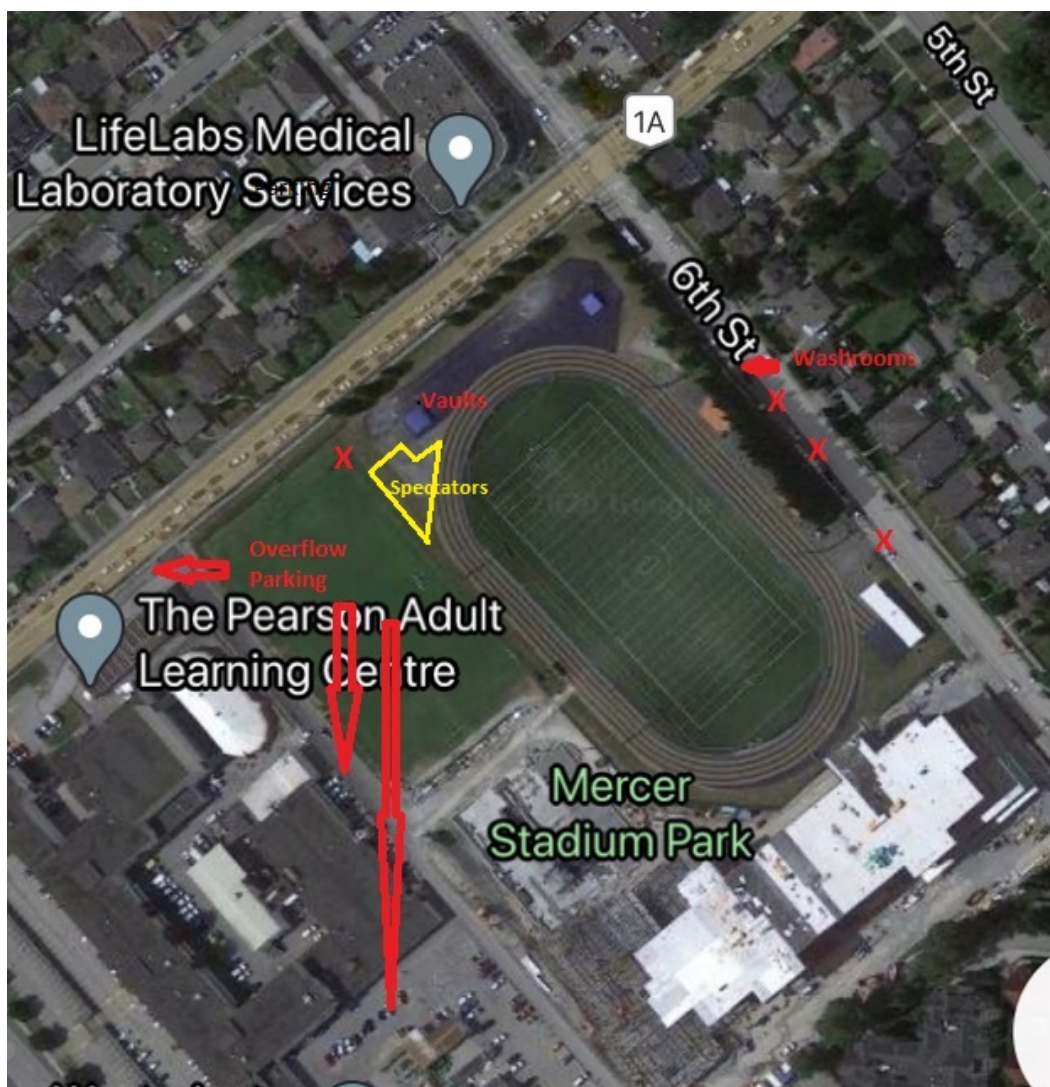


## Royal City Vault Last, Last Chance Meet

We have new school construction on this site, impacting access and parking. There is no parking on 10<sup>th</sup> Avenue, and the east side of 6<sup>th</sup> Street is by permit only. If you are unable to park on the stadium side of 6<sup>th</sup> Street, there is ample

parking around NWSS and the Pearson Centre, accessed from 10<sup>th</sup> Avenue between 6<sup>th</sup> and 8<sup>th</sup> Street. Please note you cannot turn left onto 6th Street if travelling west on 10<sup>th</sup> Avenue, you may however turn left into the parking lot. Some GPS and internet map services have an old address on 8<sup>th</sup> Avenue for Mercer Stadium; ensure you are not using this as it will only take you to the arena and Massey Theater; access beyond these buildings is currently blocked by construction.

Access to the upper west gate is from the grass field, not from the 10<sup>th</sup> Avenue sidewalk. Please respect any field sports being played.

Athletes to bring their own chairs, towel, tarp or heavy blanket and water bottle etc. As social distancing will be maintained, there will not be an athlete tent set up.

Spectators will not be allowed in the jumps area, we will have space behind the pits on the edge of the pavement / grass hill below the grass soccer field, by the high jump pits or in the stands. Social Distancing must be maintained.

Volunteers will be required for tarps.

Single event meet, decision of the officials is final, disputes to be addressed to Ian Coutts or delegate within 30 minutes of the occurrence.
