AWARDS

Medals will be presented to the 1st, 2nd, and 3rd place finishers in each event. Ribbons will be presented to 4th to 8th place finishers.

ENTRY WRISTBANDS

Wristbands will be provided in meet packages for coaches and athletes to enter the track venue and infield with their clubs. The number of COACHES wristbands will be based on the number of competing athletes and allotted as follows: <u>1 COACH WRISTBAND FOR</u> <u>EVERY 5 PARTICIPATING ATHLETES</u>. Additional coach wristbands will not be provided.

ONTARIO SUMMER GAMES

- This meet will be used as a qualifier for U14 and U16 athletes to qualify to be part of Team Ontario and participate in the Ontario Summer Games being held on July 21-24/22 at St. Marcellinus S. S in Mississauga, ON.
- Confirmation has been provided by Athletics Ontario that results from this meet can be used to meet the standards required for athlete declarations. Athlete declarations must be submitted no later than Thursday, June 16/22. Please see links below:

NOTES

- Waiver forms must be filled out on-line on Trackie for each athlete. Athletes without signed waiver forms will not be allowed to compete.
- Events with less than five athletes may be combined with another age division.

GENERAL RULES

Track events take precedence over field schedules. If the timing of the field and track event conflict, the athlete must check in at both events, notify both officials of the conflict and be ready to run when the race is started. The athlete will be able to return to the field event once they completed their race.

MEET SCHEDULE

The Meet will be conducted based on a *"rolling" schedule*. However, the order of events as listed, will be maintained unless otherwise informed. On the condition that the schedule is revised, you will receive one in your Meet Package.
