

Anti – Doping Policy

## 1. Purpose:

This policy is to provide a consistent and effective response to the use of banned substances and practices in Athletics in order to deter those who might engage in doping and to protect those who commit themselves to the practice of sport based on the principles of fair play.

Athletics Ontario and Athletics Canada are bound by the <u>Canadian Anti-Doping Program</u> (CADP) as outlined by the Canadian Centre for Ethics in Sport (CCES). The CADP is a rigorous program that ensures the accountability and transparency of all aspects of anti-doping including medical exemptions, testing, results and appeals. The CADP complies with the mandatory elements of the <u>World Anti-Doping Program</u>.

# 2. Policy:

Athletics Ontario strongly opposes the use, possession, and the supply of banned substances and practices by Ontario Athletics athletes, coaches, trainers, medical staff and other support personnel. Athletics Ontario and Athletics Canada have adopted the <a href="Canadian Anti-Doping Program">Canadian Anti-Doping Program</a> (CADP) as the anti-doping policy and regulations of the organization.

Athletics Ontario also adheres to the international IAAF standards for anti-doping administered through the World Anti – Doping Agency (WADA).
