- The requirements are for us to obtain financial accountability from the members. Our first attempt failed. We currently have 162 positive responses. To date we fall short of the required 200 for financial stability.

### **Proposed New Facility To Call Home For Stage 5**

- A Place to call home year round while we review opportunities for Stage 5
- Within City of Sarnia
- 4 Indoor Courts High Ceiling
- Possibly add 4 Outdoor Courts (if space allows) as interest warrants
- Heated (No A/C)
- Great Acrylic Court Surface
- Washroom/Changeroom (no showers)
- Proposed Kitchen Area Fridge
- Social Areas

### **Proposed Facility Costs**

### <u>Lease</u>

- 2/4 Years (with possible extension to 5 years)
- We Proposed A \$10,000 Lease Plus HST/Heat/Hydro/Water
- Total Building Cost Estimated @ \$13,000/Month = \$156,000/Year
- Need Commitment 12 Months of Year for 2 Years
- Hence The Request For Response Before We Sign Lease (Risk to club)
- No Commitment On Our Own Need To Commit As A Group Per Our Constitution (Minimum 175 from current SLPC members plus 25 from new interested players)
- Plus Improvement Costs Court Painting, Lighting, Secure Access, Any Renovations, Mesh, Nets, Salix Software, Content Insurance, Cleaning
- Need minimum \$15,000 per month revenue (\$180,000 per year)

### Players - Required Response (Yes or No)

- If interested we have a sign up sheet here tonight and at the desk at DeGroot's or respond by email to vanhemmen\_mike@yahoo.com
- If we don't get the required commitment from enough current SLPC members we will contact potential members from the original membership drive list last November whom could only play in the evening to help make up the difference. Then we would go public for an additional membership drive.
- SLPC will continue to work with the city, DeGroot's for existing club play.
- SLPC will continue with Stage 5 to obtain Indoor Facility.
- Many members are excited about our proposal and we may lose future opportunities if we don't get the required responses. You can help by contacting members you know that have not responded.

### FAQ's

- 1. Can we pay monthly? No, we are requiring pre-pay to ensure we have cash flow to pay the lease.
- 2. When do pay? Not until we have the lease agreed to, will notify by email.
- 3. How do we pay? By cheque to Sarnia Lambton Pickleball Club.
- 4. Do we pay 2 years upfront? No, we are only asking for the first year pre-pay.
- 5. Is there a couples/family membership? Not for our first year of operation. Will be reviewed for subsequent years.
- 6. Is there A/C in the building? No, we have requested an additional garage door for cross ventilation.
- 7. Court surface? Will be acrylic, requested quote for installation.
- 8. Court area? High ceilings, clearance around courts approx 5 ft sides, 8 ft ends.
- 9. Location? Within Sarnia city limits.

- Canada Pickleball Sanctioned Tournament May 03 05
- At Lambton College
- Various Categories 2.5, 3.0, 3.5, 4.0+ in Women's, Men's, and Mixed Divisions
- Open to all players registered to Pickleball Canada
- Anticipate players from across Ontario and USA
- Expect approx 200 players
- Need many volunteers

### Summer Play At Blackwell Hub

- Strangway have advised they will continue to offer their summer outdoor program.
- Strangway have Blackwell Courts Monday, Friday, & Saturday 8:30am to 10:30am, Wednesday 8:30am to 12:30pm.
- Online sign up for Strangway is 19 March, first come, first serve, get in early to get your spot.
- SLPC has applied for Courts from 9am to 1pm 7 days per week and 6pm to 8pm 5 days per week.
- Parks & Rec allocate courts per their policy which is similar to how they allocate ice time to the various associations. We have conflicts for what we asked for versus what Strangway requires the courts.
- The City has offered SLPC the 6 Blackwell Courts for club play as follows:
  - Monday to Friday 6pm to 8pm.
  - Monday, Friday, & Saturday 11:00am to 1:00pm
  - Sunday, Tuesday, Thursday 8:30/9:00am to 12:30/1:00pm.
- We have considered 3 options:
  - 1. SLPC book the courts offering structured play through Salix in accordance what members will support.
  - 2. Members play for free on a first come, first serve basis
  - 3. If Blackwell is real busy Members can book their own courts through the city

### **Details For Blackwell**

- Court rental is \$12.25 per hour per court plus GST (\$27.68 for 2 hours per court). If they accept our Insurance.
- Expected cost per member is similar to what we charge at DeGroot's (approx \$6.00 Open Play, \$30 Private Court). Risk - If we don't fill courts we have to pay city anyway. (projected cost is \$50,000)
- If interested we have a sign up sheet here tonight and at the desk at DeGroot's or respond by email to vanhemmen\_mike@yahoo.com.
- We are contemplating signup similar to the Strangway Program where you register upfront for the same time each week for the full 20 weeks. Will depend on input.
- Note that in future cancelling play within 24 hrs will not be refunded.
- Are members interested in paying for structured club play at a fee or take your chances of playing for free.
- To play for free we expect a mess at the courts with the number of new players that will go there to play via paddle up process.
- Suggestions for other city courts to go and play for free Linden Park, Cathcart Park, Baxter Park, Kenwick Park in Bright's Groove. Traditionally these courts are not booked and access is free to all via paddle up.
