## **Unacceptable Behavior**

Unacceptable behavior from any community member will not be tolerated. Unacceptable behavior includes, but is not limited to:

1. Intimidating, harassing, abusive, discriminatory, derogatory, or demeaning speech, materials, or conduct. Event venues may be shared with members of the public; please be respectful to all patrons of these locations.
2. Violence, threats of violence, or intimidating language directed against another person or group of people.
3. Harassing or otherwise discriminatory comments and language.
4. Personal insults.
5. Inappropriate photography or recording.
6. Taking of photos within the event environment for use on social media or elsewhere, without the prior permission of the individuals or owners of the content therein.
7. Lewd, or offensive behavior or language, including but not limited to using sexually explicit or offensive language, materials or conduct, or any language, behavior, or content that contains profanity, obscene gestures, or racial, religious, or ethnic slurs.
8. Failure to obey any rules or regulations of any event venue.

## **Consequences of Unacceptable Behavior**

Unacceptable Behavior will not be tolerated. Anyone asked to stop unacceptable behavior is expected to comply immediately. In response to Unacceptable Behaviour the JIBC and the LETA may take any action it deems appropriate, including warning or expelling the offender from the event with no refund and notifying the person's employer/agency or professional oversight body.
