Eligible Athletes:

- 2025 BC Athletics members.
- 2025 School Club Members – Elementary, middle, or high school non-BCA member students whose schools hold a BC Athletics School Club Membership are eligible to compete. To avoid paying the “Day of Event” insurance fee, these school athletes must enter the appropriate code into the Trackie field requesting the BCA number. Athletes can get this code from their Athletic Director or Administrator. Alternatively, a request for the code can be made by calling the Entries Chairperson. This code must be entered in the Member # field when registering, to not get charged the non-member fee.
- SD#73 has purchased an annual BC Athletics license for all public schools in the district. Therefore, these public-school non-BCA member athletes do not pay the “Day of Event” fee. Instead, they must enter a special code when it asks for their BCA membership number which will bypass that fee. Don't hesitate to get in touch with the Entries Chairperson (see below) to get that code.
- “Day of Event” School Club Members – **Elementary, middle, or high school students only**, whose schools **do not** hold a BC Athletics School Club Membership, must purchase “Day of Event” School Club Membership insurance for **\$5.00**.



- Masters athletes' age is determined as of the first day of the meet – January 1, 2025

Registration Method & Pavement:

All entries **must** be submitted by the following method:

Regular Entry Fees end on January 24, 2025 @ 8:00 pm (Local Time)

- U10 to U14 \$15.00 for the 1st event and \$10.00 for each additional event.
- U16 and older \$20.00 for the 1st event and \$15.00 for each additional event.
- For all other athletes' their age is calculated as of December 31, 2025.
 - University athletes who are members of their schools' team that is registered with BC Athletics.

Late Entry Fees end on January 31, 2025 @ 8:00 pm (Online Registration Closes)

- For all age groups \$30.00 for each event.

Administration Fee

- \$5.00 per athlete
- USport teams will be charged a maximum of \$800 per team

Late Entries may be accepted at the meet subject to space in the events so that new heats/flights do not have to be created.

\$20.00 per relay team entries submitted online and will be accepted on paper form up to 1 hour prior to the event and will not be considered late. Only complete teams should be registered online for relays.



COMPETITION RULES AND OTHER INFORMATION

COMPETITION PACKAGES:

Payment must be received before the package is released. Payment can be made at the meet for university and/or school teams. Make all cheques payable to “Kamloops Track and Field Club”. Clubs/Teams must designate a responsible person who will pick up, completely pay for the club package, and assume responsibility for the package (the Meet Secretary will **not** look after partial club packages).

COMPETITION CATEGORIES - 2025:

2025

U10 (2016), U12 (2014 - 2015), U14 (2012 - 2013), U16 (2010 - 2011), U18 (2008 - 2009), U20 (2006 - 2007), Senior (1991 - 2005), Master (1990 and earlier - 35yrs of age+)

AWARDS:

Medals will be awarded for 1st – 3rd place and ribbons will be awarded to athletes placing 4th - 6th on Oval races and 4th – 8th in field events and straight-away races for individual events only. Medals will be awarded to all relay team members from 1st – 3rd place. Awards will be available for pickup usually half an hour after events are completed and posted. They must be picked up by the end of the meet and will be available 30 minutes after the event results have been posted. **No mail-outs.**

MARSHALLING:

Check-in for all field events is at the event area. Check-in for all track events is at the start line area for the event. All athletes must check in a minimum of 30 minutes prior to the scheduled start time.

IMPLEMENTS:

Indoor shot puts will be supplied by the meet organizers. Athletes may use their own implements which must meet World Athletics standards and be suitable for throwing on hardwood flooring. They must be weighed in and measured at least 45 minutes before the competition. The weigh-in station will be located near the throws area, inside the track at the east end of the Fieldhouse.

SPIKE LENGTH:

The maximum spike length allowed is 7 mm for all events. No needle spikes will be allowed. All spikes must be either christmas tree or a pyramid.



ORDER OF EVENTS:

All track events will be run from youngest to oldest, female, then male (exception hurdles), and may start up to 30 minutes earlier than the scheduled time. **Please pay attention to announcements regarding time changes for events.**

ATHLETES WITH CONFLICTING EVENTS:

Track events will go as scheduled. Athletes or a designate must notify the officials at all events which are in conflict. Athletes in field events will forego their attempt in a round if the round has been completed before they return.

TRACK EVENTS:

All Track events will be run as **timed finals** except for some 60m age groups. Sections will be consolidated where possible. Events may be run up to 30 minutes earlier than the scheduled time. **PLEASE NOTE: 60m for U10, U12, U14, and Masters will run as Timed Finals. U16 to Senior athletes will run preliminaries only if there are more than 8 athletes in the event, with finals fitting into the schedule later the same day. **If there are fewer than 8 athletes in the preliminary race, it will be run as a timed final at the preliminary time.** Medals will be awarded from the final's times.**

FIELD EVENTS:

COMPETITIVE ATTIRE:

All athletes are encouraged to wear their club/team uniform.

PROTESTS:

After discussion with the event referee, any further protest must be submitted in writing to the Meet Director and the Jury of Appeal within 30 minutes of the posting of the results of the event concerned. A \$50.00 protest fee is to accompany all protests that are advanced to the Jury. If the protest is upheld, then the protest fee will be returned.

JURY OF APPEAL:

A Jury of Appeal consisting of three competent and qualified persons will be available for decisions arising from protests. All Jury of Appeal decisions are final.
