# Sarnia Lambton Pickleball Club London Line Facility Membership Agreement

This Membership Agreement (the "Agreement") is entered into between the Sarnia Lambton Pickleball Club ("SLPC") and the undersigned member ("Member") for the purpose of granting the Member a one-year membership to the London Line facility (the "Facility") located in Sarnia, Ontario.

By signing below, the Member agrees to the following terms and conditions:

### 1. Membership Term and Fees

- The Member agrees to pay a fee of \$720 +HST (\$813.60) on or before April 11, 2025 in exchange for a one-year membership to the London Line facility.
- The one-year term for membership will commence on a date specified by the SLPC, but will be no later than June 1, 2025.
- The membership will include **72 two-hour pickleball sessions**, with no additional fees required for those sessions.
- After the 72 sessions have been used, the Member may continue to book additional court time at a reduced court fee rate, as determined by SLPC.
- Member must choose option A or B for their 72 sessions, as described elsewhere.

### 2. Guest Policy

- The Member may bring non-SLPC members to the Facility to play pickleball, subject to the SLPC's guest policy, which will require an additional non-member fee to be paid by the guest.
- The Member agrees to ensure that their guests comply with all Facility rules and regulations and that the SLPC guest policy is adhered to.

## 4. Insurance and Club Membership

• Member's play at the Facility is subject to the Member having insurance that is acquired with SLPC membership. To maintain the required insurance coverage for play at the Facility, the Member must keep their SLPC club membership in good standing. The SLPC membership is **not** included as part of the London Line facility membership and must be maintained separately.

#### 5. Termination and Refunds

- In the event that the Member is unable to fulfill the terms of the agreement, no refunds will be provided, and the membership will remain active for the full term.
- The Member may request to terminate the membership prior to the start date by notifying SLPC in writing; however, the membership fee will not be refunded to the Member
- If, during the course of the one-year membership, the Member is no longer able to play at the Facility and still has outstanding prepaid pickleball sessions, they may transfer the

remaining membership entitlements to another SLPC member in good standing. Any such transfer must be pre-approved in writing by a member of the SLPC executive. Any payment for such transfer will be strictly between the transferor and the transferee. The transferee will be expected to accept all terms of this agreement for the balance of the one-year term.

## 6. Facility Rules and Regulations

- The Member agrees to abide by all rules and regulations set forth by SLPC at the London Line facility, including any safety guidelines, booking policies, and other rules for using the courts.
- The Member acknowledges that failure to comply with the SLPC's rules or the terms of this Agreement may result in the member no longer maintaining their SLPC membership in good standing and therefore would result with the Member being prohibited from accessing the Facility.

### 7. Liability and Waiver

• The Member agrees that SLPC and the London Line facility are not liable for any injuries or damages sustained by the Member while using the Facility. The Member understands and accepts the risks associated with pickleball and agrees to hold SLPC and the Facility harmless for any such risks.

## 8. Agreement to Terms

• By signing this Agreement, the Member acknowledges that they have read, understood, and agreed to the terms and conditions outlined above.
