CONSENT AND AGREEMENT

Warning: This is a binding legal agreement; therefore, please read carefully and clarify any questions or concerns before completing and executing this Agreement.

TERMS AND CONDITIONS

In consideration of NU Sport Federation's (NU Sport) acceptance of this Registrant Application and Agreement and other valuable consideration, the receipt and sufficiency of which is acknowledged by the parties, I agree as follows:

1. This Agreement must be signed by the Registrant and/or the Registrant's parent/guardian (if applicable, when the Registrant is younger than 19 years old) prior to participation. The Registrant acknowledges and agrees to the terms outlined in this document. When the Registrant is a minor, the Registrant's parent/guardian acknowledges and agrees to the terms on behalf of the Participant.
2. **Definitions and Interpretations:** Unless otherwise specified in the Agreement, the following terms shall have the following meanings assigned to them:
 - a. "Agreement" includes this Registrant Application and Agreement in its entirety, including the Waiver and the schedules, policies, consent and release forms included herein;
 - b. "Activities" mean any orientation, instruction, activities, programs, events, training, meets, camps and services offered by or through NU Sport and/or a Member or in which a Registrant participates;
 - c. "I", "my" and similar words and phrases herein refers to the Registrant if the Registrant is above the age of 19 years and to the parent/guardian of the Registrant on behalf of the Registrant if the Registrant is under the age of 19 years;
 - d. "Members" means all Full and Associate Members recognized by NU Sport;
 - e. "NU Sport" means the Sport Nunavut Federation and if the context requires, to NU Sport's Members, directors, officers, committee members, Registrants, employees, coaches, volunteers, representatives, officials, participants, sponsors, owners/operators of the facility in which NU Sport or a Member operates for an Activity, representatives, agents and their heirs, executors, administrators, successors and assigns;
 - f. "Premises" means the facility in which an Activity takes place;
 - g. "Registrant" means the individual who is registering with NU Sport to participate in the activities of NU Sport pursuant to this Agreement.



3. I agree that upon this application for Registrant to NU Sport being accepted, I will become a debtor to the NU Sport for the full amount of all fees and costs associated with my registration.
4. I have read, understand and agree to abide by the *NU Sport Policies, Procedures, Rules and Regulations*, and any future amendments. The *NU Sport Policies, Procedure, Rules and Regulations* are available [here](#). If the Registrant is a minor, I confirm that I have read the Policies, Procedure, Rules and Regulations, including the Code of Conduct with the Registrant and explained the requirements under such documents to the minor Registrant.
5. I acknowledge that Members may also impose additional policies and procedures related to their specific sport Activities.
6. I understand that neither NU Sport nor the Activities/Premises offer a nut-free environment and NU Sport cannot effectively monitor and guarantee that the Activities is nut-free. It is my responsibility to take the necessary precautions by ensuring that the Registrant has an individual emergency plan, including an epinephrine injector (Epi-Pen) if needed, in the event of a serious reaction.
7. I understand and agree that NU Sport shall be excused from the performance of its obligations under this Agreement to the extent that such performance is prevented by force majeure (defined below) and if it provides notice of such force majeure event to the Registrant. Such excuse shall be continued so long as the condition constituting force majeure continues. NU Sport will use its best efforts to notify the Registrant of the within 15 business days of such event anticipated duration of such force majeure, any actions being taken to avoid or minimize or mitigate its effect after such occurrence. For purposes of this Agreement, "force majeure" shall include conditions beyond the control of NU SPORT, including an act of God, acts of terrorism, voluntary or involuntary compliance with any regulation, law or order of any government, pandemic or epidemic (whether pandemic or epidemic is declared or not), war, acts of war (whether war be declared or not), labor strike or lock-out, civil commotion, failure or default of public utilities or common carriers, destruction of production facilities or materials by fire, earthquake, storm or like catastrophe. The payment of invoices due and owing hereunder shall in no event be delayed by the Registrant because of a force majeure affecting the Registrant.
8. I authorize NU Sport to take and provide all necessary medical, surgical or dental aid to the Registrant as may be necessary should the Registrant suffer an injury or illness due to his/her participation/association in the Activities.
