

CONSENT FOR USE OF PERSONAL INFORMATION, PHOTO RELEASE AND ELECTRONIC COMMUNICATIONS

Personal Information

1. I, the undersigned, authorize NU Sport to collect and use personal information provided herein for the purposes reasonably associated with the activities of NU Sport and/or its Members. These purposes, include, but are not limited to, national, territorial and event registration, insurance coverage, training and competition participation and competition result publication, age-appropriate training environment, eligibility, selection, baseline performance data, and publication on online and direct communications from NU Sport.
2. I acknowledge that if I am sanctioned in some way that restrict me (my child's) eligibility to participate in sport due to a violation of NU Sport Policies, Procedure, Rules and Regulations or those of a Member, certain identifying information may be publicly released, including my full name, category of alleged violations, nature of the violation pursuant to the NU Sport Policies, Procedure, Rules and Regulations, sanction imposed and description of the imposed sport participation restriction or sanction conditions and date of issuance of sanction and period in effect.
3. Complete texts of the Privacy/Personal Information Policies (variously the 'Policy' or the 'Policies') may be found here.
4. If you wish to review your personal information held by NU Sport or its Members, you must make a request to the appropriate organization pursuant to that organization's Privacy Policy.
5. You may withdraw consent to use your personal information pursuant to the applicable Privacy Policies, except for such information published pursuant to a sanction decision. Such a withdrawal may require the cancellation of registration with and suspension of activities with NU Sport and its Members.

Photo Release

6. I grant permission to NU Sport and its Members to photograph and/or record my image and/or voice on still or motion picture film and/or audio tape, and to use this material to promote NU Sport and its Members through the media of newsletters, websites, television, film, radio, print and/or display form. I understand that I waive any claim to remuneration for use of audio/visual materials used for these purposes. I understand that I may withdraw such consent at any time by contacting NU Sport's Privacy Officer. The Privacy Officer will advise the implications of such withdrawal.
7. I also understand and agree that external media organizations may attend Activities in order to photograph, film, audio-tape or videotape persons at the event for the purpose of being published and/or broadcast online, on television or radio. I hereby agree and give permission to be photographed, filmed, audio-taped or videotaped by external media organizations at the Activities.



Electronic Communications

10. I agree that NU Sport is not liable for any third-party incurred fees, other legal liability or any other issues or liabilities arising from statements or notifications sent to an invalid or inactive email address that I have provided.
