### Proposed Bylaw Changes to Red Deer Pickleball Club Bylaws

#### Mission Statement-

Current- The mission of the Red Deer Pickleball Club is to work with Pickleball Canada and Pickleball Alberta in the growth and development of the sport of pickleball for all ages.

Proposed- The mission of the Red Deer Pickleball Club is to facilitate the growth of pickleball in Central Alberta for the enjoyment, health and social engagement of players of all ages by offering recreational and competitive play.

- 2.1 Current- The Board of Directors of the Society(hereinafter referred to as "the Board") shall consist of the following Director positions:
- a. President
- b. Vice President
- c. Secretary
- d. Treasurer
- e. Up to 5 Directors at Large
- 2.1 Proposed- The Board of Directors of the Society (hereinafter referred to as "the Board") shall consist of the following Director positions:
  - a. President
  - b. Vice President
  - c. Secretary
  - d. Treasurer
  - e. Up to 8 Directors at Large
- 2.8 Current- Any Director, upon a majority vote of all members in good standing, may be removed from office for any cause which the Society may deem reasonable.
- 2.8 Proposed- Any Director, upon a majority vote of the Board in good standing, may be removed from office for any cause which the Society may deem reasonable.

- 2.16 Current- The fiscal year of the Society in each year shall be May 1 to April 30.
- 2.16 Proposed- The fiscal year of the Society in each year shall be from Jan 1 to December 31.
- 3.18 Current- A quorum of 10 members is required for an Annual General Meeting.
- 3.18 Proposed- A quorum for all General and Special meetings shall be the lesser of 20 or 10% of all members in good standing, present in person, or by online attendance at the start of the meeting.
- 3.2.4 Current- A quorum of 10 members is required for any General Meeting or Special Meeting.
- **3.2.4 Proposed** A quorum of 20 members is required for any General Meeting or Special Meeting
- 3.3.2 Current- is in 3 separate paragraphs
- 3.3.2 Proposed- now 1 paragraph
- 3.4.1- Current- Any member who has not withdrawn from membership nor has been suspended or removed from membership and who has paid all required membership fees applicable to the current year shall have the right to vote at any General or Special meeting of the Society. Such votes must be made in person and not by proxy or otherwise.
- 3.4.1. Proposed- Any member who has not withdrawn from membership nor has been suspended or removed from membership and who has paid all required membership fees applicable to the current year shall have the right to vote at any General or Special meetings of the Society. Such votes must be made in person or online and not by proxy.
