## Reports:

Financial Report: The Treasurer, Colin reported that as of June 5, 2023, there is a balance of $\$ 927.05$ when all current commitments to the end of September are deducted. See attachment entitled SCPC POSSIBLE COURT COSTS 2023.

Communications Report: No correspondence to report.
On-line calendar - Shannon reported the clickable calendar is \$10USD per month and easy to adapt. This cost was discussed and approved by board members via email
Brochures - Maureen reported the brochures were distributed at Ken Holman's 3 lessons
Newsletter - $91 \%$ of members opened the newsletter.

Reserved Signs - posted when SCPC has the courts reserved for clarity for all players.
Membership Report: Currently SCPC has 119 members, 8 of whom are out of the area. Kerry Park suggested $10 \%$ or less of membership can be non-locals to ensure the courts are serving local tax payers as required by the CVRD.

Social Report: Linda motioned that "The club offer a Bevy and Burger event for $\$ 15$ on June $29^{\text {th }}$ at Kerry Park". Seconded by Shannon. MOTION CARRIED. The event will be advertised on Facebook and our website. There will be organized, social play from 10-12 beforehand. If this is a success, the club will consider doing another Bevy and Burger event the last Thursday in July. Laurie to advise Kim Liddle of this request. Twenty people may participate.

## Business Arising from Minutes:

1. Court times/bookings: Kerry Park agreed to offer Saturday morning to the club, not Sunday as it is already booked by a couple of groups. We will also book two courts for women and two courts for men's play on Friday evening and gauge the interest.
Saturdays will be mixed doubles round robin.
