1. Treasurer's Report:

2. Update on Gord's Presentation to City Council – Permanent Courts:

Gord is out of town until early December and Caroline Sparks has been unavailable to meet with Gord or Hector due to other commitments and constraints on her time.

Given the delay and the importance of moving ahead to make a presentation to City Council the Board will start to prepare an outline and a draft Power Point presentation for Gord's review and input. Hector will contact Gord to let him know our intentions.

3. Contacting Inactive Members: Why are they not renewing :

We would like to get some feedback from those members who have not signed for Takhini and from those who have not renewed their memberships from last year. Jim has made some direct communication with some members who have since signed up for Takhini. He has volunteered to draft a note to members who have not renewed, ask for feedback and pass on programming that is happening this indoor season.

4. January 6, 2024, Tournament Format / Planning:

Presently we will have 6 courts at the CGC and will go with two levels – Intermediate and Open divisions, with possibly 24 in each division. We still need to sort out the exact format to maximize participation for those who sign up. Given the time constraints we may have to limit games to 15 minutes. We will have further discussion and a notice of the tournament going out in November. There may be a possibility of a Novice tournament the on the same date if we get Elijah Smith for the Christmas Break.

Hector will confirm our needs with Jeremy at the CGC. We will use the same process for Tournament Registration (\$15) through our website. An automatic reminder will be coming to members from PCO to renew their annual membership which expirees at the end of December. YPA will send a reminder to sign up for the Winter Takhini pass.
