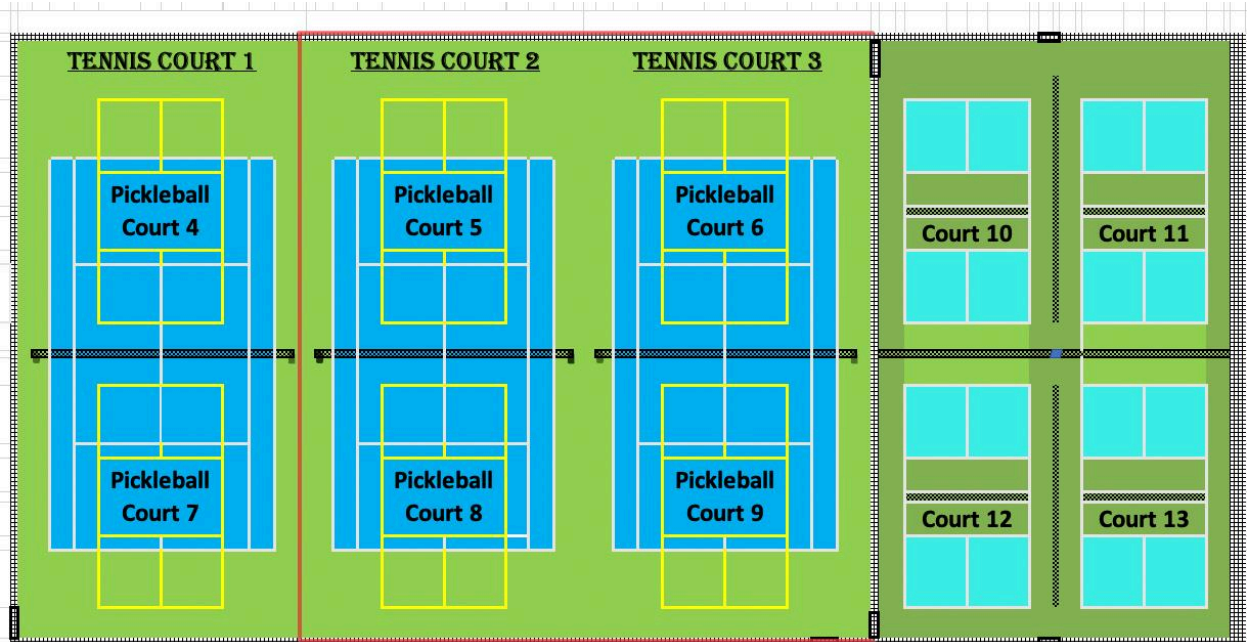
AGM Tournament - Our club fun tournament will again be held before the AGM. This will also be at Cromie Park, starting at 9:00am with Partner Play and at around 11:30 for the Singles. Partner play will be limited to 16 teams. Sign up is now available on Play Time Scheduler for both partner and singles categories. Entry fee is \$10 each, payable in cash at the tournament. There will be cash prizes for winners.

Tsawwassen Sun Festival Tournament - results - disappointing numbers - only 16 players - therefore held the 3.0>3.5 portion only - but everyone had a great time and there were lots of spectators. Thanks to Don T, Dave S, Flo MB, and George P for helping out.

Dennison Court Lighting - unfortunately we still have no firm dates when these upgrades will be done. Further details will be posted on our website in the when it becomes available

Cromie Sounds Barriers - the new layout will include 8 courts for general pickleball use without 'quiet' paddle restrictions. There will be 6 **dedicated** pickleball courts in total, including new dedicated courts 6 & 9, plus 4 courts shared with tennis: courts 5 & 8 within the sound barrier and 4 & 7 outside outside of the sound barrier. Quiet pickleball equipment will only be required on courts 4 & 7, as they are closest to houses and outside the sound barrier. Tennis court 1 is usually used for tennis so we don't see this as a problem. DPA will do everything in our power to stop DPA members from playing on courts 4 & 7 with non-quiet equipment. Use of regular equipment and noise complaints on these courts will jeopardize pickleball play at Cromie. Be kind and get along with the neighbours! This work is currently planned for this fall.

The U shaped sound barrier will be placed around the new perimeter fencing (but not covering the access doors) as shown in red below:



DPA is hoping to get permits for 5 of the 6 dedicated courts plus 1 of the 2 shared courts - providing during DPA sessions, if DPA players are also using the remaining vacant 'public' courts, these court must immediately be vacated when 'public' players are wanting to play. You must let them use the dedicated courts and not just direct them to use the 'shared' courts (5 & 8). This policy must be made clear and confirmed by all Cromie court hosts.

New Opportunities for 3.75 Players for - Effective immediately, for some 4.0+ sessions at Cromie Park, **DPA approved 3.75** players can register, but **only if the session is not full 24 hours before**. Any 3.75 players without a DPA approved rating or registering before this cut off time will be removed.

DUPR - We will be starting test DUPR sessions soon, and hopefully be able to offer many more starting in the spring. Players will need to agree to participate and individually register (free) at dupr.com. Our Play Level tab on our website will be upgraded to reflect various options available for members to obtain at 3.75+ club rating.
