Memorandum of Association

For a Non-Profit Society

The name of the Society is the **RIVER JOHN PICKLEBALL CLUB**

On a volunteer and non-profit basis, the objectives of the society are:

- To promote and support the growth of pickleball as a sport for all ages and abilities in River John and surrounding areas;
- To acquire by way of grant, gift, purchase, bequest, devise or otherwise, real and personal property and to use and apply such property to the realization of the objects of the Society;
- To buy, own, lease, mortgage, sell and convey such real and personal property as may be necessary or desirable in the carrying out of the objects of the Society.

Provided that:

- The society shall not carry on any trade, industry, or business;
