This means that the number of courts at Cromie will be reduced for the winter. We have removed the wind barriers on the south side which ensures that the four permanent courts at Cromie are available. This short term pain will yield significant benefits for our club in the Spring.

## **Player Ratings Editorial**

Whether some of you know this or not, player ratings can be and often are the most controversial subject in pickleball clubs. After scouring the internet, Reddit, Facebook, and many other sources for hours, I was unable to find the "magic bullet" that other clubs have used to deal with this issue. Clubs report that members report "self rated" ratings that are not corroborated with recent and relevant tournament play that are .25 - .75 higher than their actual ability. Our club is no exception.

On one hand the issue is simple (the actual ratings part) and on another, quite complex (who we all want to play with and more importantly, socialize with and enjoy each other's company). Why are ratings relatively simple? The USPA has established guidelines for different levels that outline the skills that you need to be able to do while on the pickleball court (not just in drill or practice sessions). They are also relatively simple in that we have a competitive process in tournaments that give you real world feedback on how you compete at your chosen level of play.

What is more complex is the most important part, which is who we choose to want to play with. As a club, we value this decision as it supports the most important reasons that we all play pickleball and that is to have fun and socialize with others. If someone is at a lower or higher rating level but we like playing together, then that is ok, in fact it is good! If someone is growing older and struggling to play at their historical level do we "uninvite them"? I think not. Pickleball ratings do not have "adjustments" for age, gender or both so how does this factor into how we set rules on suitability of sessions. At the end of the day, my belief is that we need to first focus on having fun at pickleball and then seek the level of competitiveness we desire.

As a Board, we have committed to coming up with some ideas that we intend to try during the season regarding ratings and competitiveness. We don't expect to come up with a "one size" fits all approach that works and as such we will be looking to try a few different things. As we develop more clarity to this approach, we will be announcing these initiatives to you. In the meantime, I would ask all of our members to reflect upon your stated rating and ensure that you are comfortable with it.

**Summary** – It has been amazing so far this winter with the weather cooperating so well for pickleball. While it has been cold, the sun has been shining and the courts have been full. Please remember to be patient and gracious to each other with our courts at full capacity.
