#### **Election of Officers**

#### **Voting Process**

All voting will be done and tabulated electronically on Zoom, therefore scrutineers are not required.

If multiple people are watching on one device, additional voting is done by scanning the QR Code which will be displayed after the people at the Zoom device have submitted their ballots.

QR Code voting requires that an email address be added for verification.

#### **Voting Procedures**

First, those with access to the Zoom console session will vote.

Second, others present at same location will vote using the QR Code scan.

Results will be displayed on the Zoom screen for all to view. The results are also saved to a disc file.

The term is up for the office of President. One application for President was received and that was from Barb Lobo.
