1. Call to order at 1:15 pm
2. Land Acknowledgement
3. Approval of previous minutes (May 22, 2025) Approved.
4. Update on Shed construction and meeting with Kim
 - a. Although the shed has been constructed by KP employees, a number of deficits have been noted. Becky met with Kim, Kerry Park Manager, about this just this morning. Kim was receptive to hearing about the deficits. This is being looked into on their end.
