Annual Election of Directors – Procedures

Procedures:

- As all Directors of the Bath PB Club serve 2-year terms, on the expiration of their term they will be up for reelection should they want to put their name forward to serve for another term.
- It is understood that these terms are usually staggered, and that all Directors are not up for election at the same time.
- Annually, any member can submit their name for consideration to serve on the Board. Typically, no less than 2 weeks prior to the AGM, any member can submit their name for consideration to serve on the board. Candidates will be required to submit a brief bio (not more than one page) for the membership's consideration and information. Members will be required to submit a brief Bio (not more than 1 page) for the membership's consideration and information.
- All returning Directors whose term has expired, but want to serve again, must also submit a new Bio.
- The Board of Directors is comprised of a minimum of three (3) members, with a maximum of five (5) members.
- Should there be for example: 4 members name put forward (5 positions in total) all 4 members will be acclaimed, and no vote will be taken. The acclaimed people will be announced to the membership present at the AGM.
- Should there be for example: 7 members names put forward for a maximum of 5 positions, a written ballot with all names on it will be distributed for a vote. (A generic ballot has been developed).
- Volunteers from the membership (not including anyone running for the Board) will be recruited to count the ballots while the AGM continues.
- The goal will be to announce the successful candidates by the end of the AGM.
- Ballots should be kept for 1 week and destroyed after that. The ranking of candidates will NOT be announced, however if an individual candidate wants that information it will be provided to them.
- The Election will be run by the Chairperson of the Board, unless he or she is running for reelection. In that case he/she will designate another Board member who is not running, to oversee the Election.
